



## #MuthHoliday Contest Rules:

**Contest starts the week of November 25 and runs through December 16, 2019.** Once a week, Zehnder's and Bronner's will each post a mini contest on their official Facebook fan pages (@Zehnders and @BronnersChristmas) for 3 weeks with the hashtag #MuthHoliday.
